

## **Technology Training Centre Report for MPTA AGM 15/03/16**

The Technology Training Centre was established in 2007 and is a wholly owned subsidiary of MPTA. It's sole purpose is to deliver training and development initiatives to MPTA Members and other interested parties.

## 2015 Course Activity:

The challenges to secure participants on training courses continued throughout 2015. The number of courses that got off the ground were down 37% on the prior year and course attendance numbers down by a massive 42% - resulting in 81 less participants being trained in 2015 than the previous year. Naturally, this has resulted in a reduced income of almost \$54,000.00 or 27% to \$141,212.07. It is acknowledged that the reduced payout announcements throughout the year have a direct effect on our Members revenue, and expenditure is tightly controlled at these times. Unfortunately, the coming season is not looking to bring much reprieve.

Water courses, which have proved popular in the past, have taken the biggest hit - with 16 courses being run in 2014 reduced to only 5 water courses run in the 2015.

It is noted that 17% of all course registrations in 2015 came from non-MPTA Members.

Although our revenue has significantly declined on the previous year I am pleased to report that an amount of \$47,401 + gst will shortly be transferred to MPTA for 2015 Course Royalties – this is a charge for Technology Training Centre to use MPTA's course material and IP each year.

## **Financial Report:**

As at 10/03/16 TTC has \$62,021.22 cash in the bank, plus debtors of \$12,866.40, less creditors of \$9,209.42 - giving a net position of \$65,678.20 - of which we are to pay the Royalties amount to MPTA
