

Training Report for MPTA AGM 31/03/2022

2021 Course Activity: Covid-19 returned with a vengeance in the second half of 2021 which again impacted many Member businesses and, consequently, resulted in a number of our courses being cancelled. However, with the requirement for all existing milking machine testers to re-train in the new MPTA ISO testing methods this boosted trainee numbers and income to pre-Covid days. This has contributed towards recovering some of the costs of the entire ISO conversion project which has been approx. \$165,000 to date.

The new ISO training delivers a much more professional and modern learning platform with digital screens and online learning components. The new AutoRep Plus app for ISO testing features a much more modern and exciting interface to the way test reports are presented.

Our latest project is the conversion of our Milking Machine Testing Standards manual into digital format. This will allow a user to enter machine details into the app and it will automatically pull the related standards for the equipment entered.
